3. **CLARIFICATIONS ON DRAWINGS**

- (i) In drawings for OR (G+3) accommodation levels of various floors shall be all as shown in drawing No. TD-OR-G+3-ELE-06 sheet No. 6 "FRONT ELEVATION" and shall be followed accordingly and levels of various floors shown in other drawings of OR (G+3) shall be treated as "Null and Void".
- (ii) Irrespective of whatever is shown on drawings, in all the drawings, mentioned at Sl. No.1 to 5 and Sl. No. 10 to 13 on Sl. Page No. 321 (R) (R) i.e. the list of drawings, the date of revisions and number of revisions mentioned on these drawings shall be treated as cancelled.

4. Srl page Nos. 321 (R) to 324 (R) are hereby cancelled and replaced with revised Sl. Page Nos. 321(R) (R) to 324(R) (R) respectively. Revised pages are enclosed herewith.
